
TRS-80 Acoustic Coupler for use with the Model 100

The Model 100 Acoustic Coupler enables your Model 100 to be connected to a telephone that does not allow direct connect (such as a phone in a telephone booth).

When using or handling the Acoustic Coupler, keep the following points in mind:

- Avoid excessive strain on the coupler cable. Place the coupler units as close to the telephone as possible. Do not tug on the cable.
- Before you plug the DIN connector into the Model 100, make sure the Acoustic Cups are attached to the coupler cable first. If you're not using the acoustic modem, make sure the DIN connector is disconnected from the Model 100.
- Do not use the Acoustic Coupler with any telephones, other than rotary-dial orpushbutton types with standard handsets.
- While data is being received or transmitted through the coupler units, do not touch the
 coupler units or subject the cups to significant vibration and noise. This helps prevent
 data errors. The same precautions should be observed with the desk upon which the
 coupler units are placed.
- The condition of the telephone line might sometimes disturb the transmission through the Acoustic Coupler. If the line fails, call again.

Connecting the Acoustic Coupler to the Model 100

- Connect the speaker plug, located at one end of the coupler cable set, to the speaker unit. (Refer to the illustration on page 1.)
- Connect the DIN connector to the PHONE connector on the rear side of your Model 100.
- Place the microphone unit securely over the earpiece of a standard telephone handset; then place the speaker unit over the mouthpiece of the handset.

Note: Be sure that the units are firmly linked with the handset, or poor acoustic characteristics will result.

Align the coupler cable perpendicular to the coupling units and the handset



 When the microphone and speaker units are coupled to the handset, place them on a flat surface, shown in Figure 2.

Note: Avoid laying the handset on its side on any hard surface, such as a desk, since this will allow exterior vibrations to be picked up; thus, data errors could result. When possible, it is highly recommended that the Acoustic Coupler units be placed on a one-inch thick piece of low-density foam.

 Set the DIR/ACP switch on your Model 100 to ACP. Connection is now complete and the Model 100 is ready for use.
